As you may have already heard, due to Governor Evers' Safer at Home order that was issued earlier this week, the Job Centers are now closed to the public, effective March 25th. Issues like password resets, or if you are using a different email or phone number than you used during a previous claim, must be handled by calling the IT Solution Center at 608-266-7252 -option 5. Unfortunately, at this time there is no other way to resolve this issue. If you do not have internet access or if you have otherwise been directed to contact Unemployment directly, you must call 844-910-3661 or 414-435-7069.
